

## 2021 White Spot & Vancouver Island Brewing Stargazing Prize Pack Contest OFFICIAL RULES AND REGULATIONS

**Open to residents of British Columbia only, 19+.** Please read these official contest rules (the “Rules”) in their entirety before entering this contest (the “Contest”). Do not enter the Contest unless you agree to these Rules. Participation in the Contest constitutes full and unconditional agreement and acceptance of these Rules which are final on all matters relating to the Contest.

**1.HOW TO ENTER THE CONTEST:** Entrants must enter the Contest by submitting an Online Entry (form at <https://www.whitespot.ca/vancouver-island-brewing-contest/>). No purchase is necessary to enter the Contest.

**2.CONTEST ELIGIBILITY:** The Contest is open only to residents of British Columbia, 19 years or older and excludes all employees of White Spot Restaurants, its advertising and promotional agencies, partners and associated entities and subsidiaries, affiliates, representatives and agents of the aforementioned parties, and a member of any such employee’s immediate family (regardless of where they live) or persons with whom they are domiciled (whether related to the employee or not). In these Rules, “immediate family” includes mother, father, brothers, sisters, sons, daughters, partner or spouse. The Sponsors reserve the right, in its sole and absolute discretion, to require proof of identity and/or eligibility (in a form acceptable to the Sponsors – including, without limitation, government issued photo identification): (i) for the purposes of verifying an individual’s eligibility to participate in this Contest; (ii) for the purposes of verifying the eligibility and/or legitimacy of any entry or other information entered (or purportedly entered) for the purposes of this Contest; and/or (iii) for any other reason the Sponsor deems necessary, in its sole and absolute discretion, for the purposes of administering this Contest in accordance with these Rules. Failure to provide such proof to the complete satisfaction of the Sponsor within the timeline specified by the Sponsor may result in disqualification in the sole and absolute discretion of the Sponsor.

**3.CONTEST CLOSE DATE:** To be eligible, entries must be received within the contest period from Monday, November 15, 2021 through to 11:59 PM (PST) Tuesday November 30, 2021 - the “Contest Close Date”.

**4.PRIZE DESCRIPTION:** There is one (1) prize consisting of one (1) Celestron PowerSeeker Telescope (value \$249) courtesy of Vancouver Island Brewing and one (1) \$200 White Spot Gift Card courtesy of White Spot. Total prize value \$449, excluding taxes. Prize includes delivery/shipping to winners BC address.

**5.PRIZE SUBSTITUTION:** The prizes are non-exchangeable, non-transferable, non-refundable, has no cash surrender value, and must be accepted as awarded with no substitutions.

**6.DELIVERY OF PRIZING:** Prize awarded includes costs associated with delivery/shipping to winner’s BC address shipped directly from White Spot Home Office, Vancouver.

**7.RANDOM DRAW:** One (1) eligible prize winner will be selected by random draw from all eligible entries received. The odds of being selected depend on the total number of eligible entries received. The first contact will be attempted by e-mail within forty-eight (48) hours of the draw and, if unsuccessful, further attempts to contact the eligible winner will be made on three (3) further occasions by telephone, social media identifier (or by the applicable account) or e-mail, at the discretion of the Sponsor. In the event that an eligible winner is disqualified for any reason, the prize may be awarded to an alternate winner by random draw from among all remaining eligible Contest entries. If no eligible winner claims his or her prize, the prize will be forfeited and will not be awarded.

**8.GENERAL CONDITIONS:** To win, the eligible winner must first have complied with the Rules and correctly answered, unaided, a time limited skill testing question to be administered by e-mail, or

telephone. Contest entries that are generated by any unauthorized mechanical or automated means will be void. Entry materials that have been tampered with, reproduced, falsified or altered are void. Any attempt to undermine the legitimate operation of this Contest is a violation of law and may be subject to remedies and damages, including criminal prosecution. This Contest is subject to all federal, provincial and municipal laws of Canada. This Contest is void where prohibited. Each entrant acknowledges that the Contest is in no way sponsored, endorsed or administered by, or associated with, Instagram Inc. or Facebook.
